



CERTIFICATION APPLICATION INSTRUCTIONS Fire Fighter 2 (2019) Certification

Overview

The California Office of the State Fire Marshal (OSFM) Fire Fighter 2 (2019) Certification is based on the NFPA 1001: Fire Fighter II professional qualifications set by the National Fire Protection Association (NFPA).

The Fire Fighter 2 (2019) Certification Application is for applicants who have completed the Fire Fighter 2 (2019) academic training or for those who have qualify as an alternate delivery candidate. Review the Certification Exam Eligibility Requirements Information Bulletin for more information.

Upgrade applicants who have a California OSFM Fire Fighter 2 Certification issued within 10 years of the date of submitting this application and are seeking IFSAC/Pro Board certification shall apply using the Fire Fighter 2 (2019) Upgrade Application.

Reciprocity applicants who have an IFSAC and/or Pro Board accredited Fire Fighter 2 certification and are seeking California (OSFM) Fire Fighter 1 Certification shall apply using the Fire Fighter 2 (2019) Reciprocity Application.

Certification Task Books

• Fire Fighter Certification Task Book (2019)

Experience (one of the following four options)

- Have a minimum of six months' full-time paid experience in a recognized fire agency in California as a Fire Fighter performing suppression duties
- Have a minimum of one year's volunteer or part-time paid experience in a recognized fire agency in California as a Fire Fighter performing suppression duties
- Have a minimum of one year's internship experience in a recognized fire agency in California as a Fire Fighter performing suppression duties (one year = three semesters or four quarters of an academic calendar)
- Have a combination of full-time paid and volunteer or part-time paid experience equal to six months' full-time paid experience in a recognized fire agency in California as a Fire

Fighter performing suppression duties (volunteer or part-time paid to full-time paid ratio is 2:1 (for example, two months' volunteer or part-time paid = one month full-time paid))

Position

 Appointed to a position performing suppression duties in a recognized fire agency in California

Application Process

- 1. Applicant mails the Fire Fighter 2 (2019) Certification Application, supporting documentation, and fee(s) to: State Fire Training, Fire Fighter 2 Certification, PO Box 944246, Sacramento, CA 94244-2460.
- 2. State Fire Training conducts an application review.
 - o If the applicant does not meet the eligibility requirements, SFT issues a denial.
 - o If the applicant meets the eligibility requirements, SFT issues the digital certification(s) through the applicant's SFT User Portal.
